### PERSONAL DATA PROTECTION APPLICATION FORM

#### GENERAL MATTERS

By way of the Applicant's sending a printed copy of this form, which should be affixed by the Applicant the "secure electronic signature" thereof as defined within the Electronic Signatures Act No. 5070 to the registered electronic mail address of Besiktas Sportif Urunler Sanayi ve Ticaret A.S.
